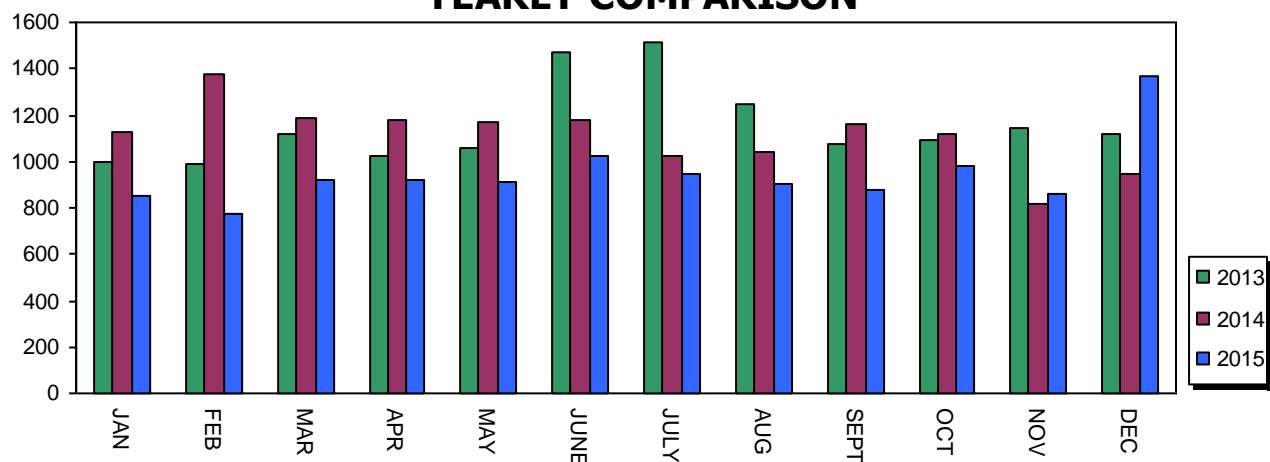

## MONTHLY CALL FOR SERVICE YEARLY COMPARISON



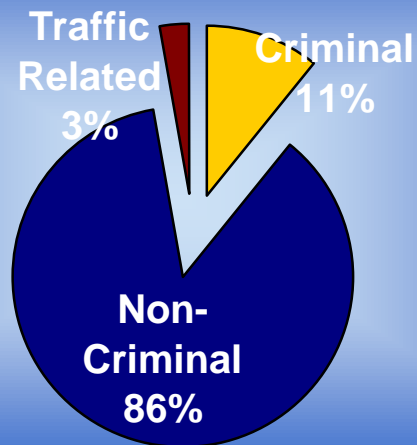

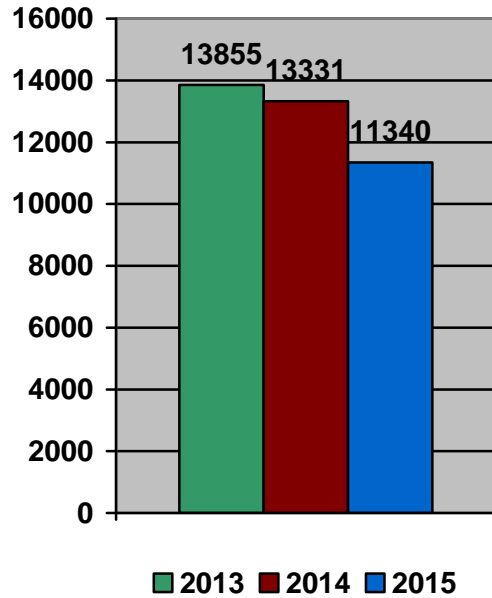
Approximately 86% of the calls handled by the Officers in 2015 are considered Non-Criminal in nature. These calls can be anything from assisting other departments; such as the Fire/Rescue Department, the Henry County Sheriff and other agencies outside the City of Napoleon; to unlocks, beat and bike patrols, and civil assists. We also conduct school patrols, building checks and public relation talks. Any call that an arrest cannot be made should be considered non-criminal.



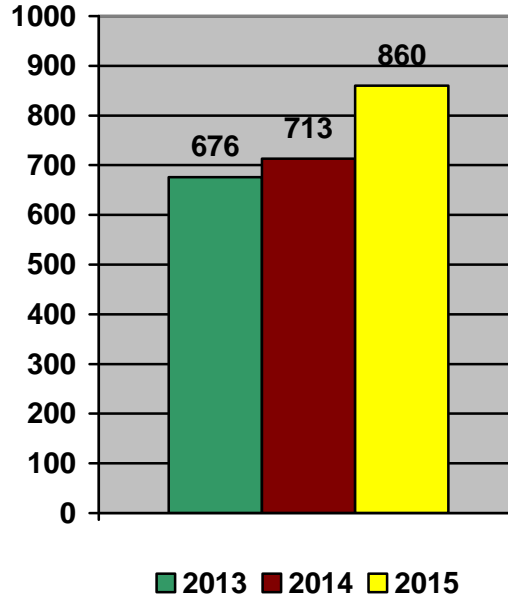

### **NAPOLEON POLICE DEPARTMENT** **DETECTIVES BUREAU** *SUMMARY REPORT 2015*

As of 2015 The City Napoleon Detective Division currently consists of one Lieutenant, as the direct supervisor, and two Detectives. The Detective Division investigated or assisted with investigation in over 457 cases. These numbers are not to represent a total call volume for the entire Police Dept. but are instead estimated call numbers for one division. The cases will be broke down into four major categories.

- Crimes Against Persons
- Property Crimes/Fraud
- Narcotics
- Special Assignments



## NAPOLÉON POLICE DEPARTMENT REPORT FOR THE YEAR 2015



### **Crimes against Persons:**

The City of Napoleon Detective Division was involved with in twenty seven (27) sex complaints. Some examples of this would be Gross Sexual Imposition, Sexual Imposition, Pandering sexually oriented material involving a minor, etc.... Out of the general sex complaints there were four Rapes investigated through the division. The Division assisted or directly investigated three Domestic Violence complaints. Tthree Menacing by Stalking, four Felonious Assaults and one Misdemeanor Assault had been worked through the Division as well as twenty three Child Abuse/Endangerment complaints. The Division assisted with one Kidnapping complaint, four Aggravated Menacing complaints, and one Robbery. One Reckless Homicide was investigated by the Bureau as well.

### **Property Crimes/Fraud:**

The City of Napoleon Detective Division was involved with fifty two (52) Breaking and Entering's and Burglaries. The Division was involved with sixty one (61) felony thefts and five misdemeanor thefts. Two Criminal Damaging/Mischief complaints were investigated by the Division. One Receiving Stolen Property complaint was also investigated that resulted in recovering numerous items stolen from the new High School building project. Five Fraud, one Forgery, and one Criminal Trespass investigations were completed through the Bureau.

### **Narcotics:**

This year The City of Napoleon Detective Division was able to place a second Detective within the Multi Agency Narcotics Unit. This placement resulted in The City of Napoleon Detective Division investigating or coordinated the investigation of over ninety (90) Narcotic complaints. As mentioned before this number is not to reflect a total call number for the entire Police Department. As a member of the Multi-Area Narcotics Task Force, the second Detective has worked closely with the FBI, DEA, and Henry County K9 Deputy; to include a prostitution/human trafficking sting and other ongoing investigations. Five narcotic overdoses have been investigated in 2015, which two of those were fatal. The Multi-Area Narcotics Agent has investigated ten Narcotics Trafficking complaints and conducted fourteen (14) searches, by either warrant or consent, within the City of Napoleon. The Multi-Area Narcotics Agent has also assisted in seventy four (74) Narcotics complaints within the five county area in which it covers.

### **Special Assignments:**

The City of Napoleon Detective conducted background checks of potential new hires for the Napoleon Fire Department, the Napoleon Police Department, and the City Law Director were completed.

The Division is now responsible for Municipal Court documents to be delivered and prepared for each court date. As it comes to Common Pleas Court, this Division is responsible for all charged felony offenses to be prepared and reviewed with the County Prosecutor for Grand Jury. The Detective is responsible for any follow up needed by the County Prosecutor or City Prosecutor when it comes to charged offenses.

The Division is responsible for any evidence that is taken during an investigation whether it is an Officer or Detective that has seized the items. When testing of any type is needed, the Division transports the evidence to the Bowling Green BCI and brings back anything that has been completed. Any polygraph examinations needed are conducted at BCI of Bowling Green and are scheduled and attended by the Detective.
